### **Annual Pass Requirements:**

- Each person must fill out an Annual Pass Application.
- Annual passes are good for one year from the date of Annual Pass application. Annual Passes must be renewed annually.
- During every visit, the Annual Pass (sent upon receipt of signed application) must be placed on your car dashboard.
- Any guests of Annual Pass holders must fill out a Registration envelope and deposit with the \$7/guest admission fee in the Registration box on the bulletin board in the parking areas.
- This is a non-exclusive and restricted use pass to Earth Sanctuary.

#### Protocol – Rules for Earth Sanctuary Property

For the safety of visitors and the protection of all living beings, the following rules must be followed while on Earth Sanctuary property. Not following these rules will result in cancellation of this Annual Pass.

- For safety reasons, children must be closely supervised by adult at all times.
- No dogs, horses, ATV's, bikes, etc.
- Hiking is permitted only on cleared trails. Remain outside of marked ecologically sensitive areas.
- Be sensitive to birds and wildlife. Do not disturb any animals or birds, especially in nesting and breeding season. Abstain from killing any being or animal.
- No canoeing, wading, or swimming is allowed in any of the ponds. No one is allowed on the bog island for any reason.
- Abstain from stealing, sexual activity, and telling lies.
- No illegal drugs, intoxicants, or firearms are permitted.
- Smoking and chewing tobacco is not permitted anywhere on Earth Sanctuary property except in the context of Native American ceremonies.
- No moving of objects on the grounds.
- Park in designated areas only.
- Please treat the grounds with care and respect. Return your area to the condition in which you found it or better.
